Location of fire extinguishers (minimum 2A-10BC) shall be provided NFPA 1126 Chapter 8.

Show location of exits, exit signs, accessible egress routes and emergency lighting.

Identify decorative materials meeting the flame propagation standards of NFPA 701 and may not exceed 10% of the aggregate of the wall and ceiling space. Any ceiling mounted decorative materials shall be positioned so as not to obstruct sprinkler discharge (IFC 807, 907).

Note on floor plan that disabling alarms or obstructing the fire alarm system is not permissible.

Note on floor plan that a site inspection is required after set-up and prior to the event. Contact the Fire District to schedule the inspection.

- ✓ Verify compliance with all permit conditions, including those governing pyrotechnics and other special effects.
- ✓ Direct and assist the event attendees in evacuation during an emergency and assist response personnel when requested.
- Other duties required by the fire code official and as specified in the fire safety plan.
